I understand and accept the fact that alpine skiing in its various forms is a hazardous sport, and I realize that injuries are a common occurrence. I agree, as a condition of being allowed to use the area facility, that I freely accept and voluntarily assume all risks of personal injury or death or property damage, and release Peak Resorts, Inc., its subsidiaries and its agents, employees, directors, officers, shareholders, and the manufacturers and distributors of equipment (collective "providers"), from any and all liability for personal injury, death or property damage which results in any way from negligence, conditions on or about the premises, the operation of the area including, but not limited to grooming, snowmaking, lift operations, actions or omissions of employees or agents of the areas, or my participation in skiing, snowboarding, blading, accepting myself the full responsibility. I further agree to defend and indemnify providers for any loss or damage, including any that results from claims or lawsuits for personal injury, death and property loss and damage related in any way to the use of equipment.

I hereby acknowledge that boarding competitions and racing in its various forms is a dangerous sport, and courses and terrain parks may be icy, rutted, and/or bumpy. I am aware that by using terrain features and/or a competition course, I assume the risk of this competition and the condition of the terrain features and the course, including the risk of falling or colliding with persons or objects. I understand that my participation in these activities can result in serious injury.

This agreement is governed by the applicable law of this state or province. If any provision of this agreement is determined to be unenforceable; all other provisions shall be given full force and effect. I am signing this agreement freely and of my own accord, realizing it is binding effect upon myself, my heirs and assigns, and in the event that I am signing it on behalf of any minors, that I have full authority to do so, realizing its binding effect on them as well as myself. I further agree that any claim or suit that I may bring for any reason against the ski area, its owners, affiliates, employees and agents shall be submitted to the jurisdiction of the State or Federal Court in the state in which the ski area is located and no other jurisdiction, and shall be governed by the laws of the state. I agree that if any portion of this agreement is determined to be unenforceable by a court of law, all other parts of the agreement shall remain in full force and effect.
