2017-2018 (200+) Corporate Partner Program Sales Agreement

Please review the following program perimeters to complete your enrollment in the Corporate Partner Program. Any questions regarding these guidelines as listed may be directed to the Paoli Peaks Sales Director listed at the end of the agreement.

Program Enrollment

To be eligible to enroll in the Paoli Peaks Corporate Partner Program companies must have at least 200 employees. Upon enrollment, a company representative must be designated to internally manage the program including communications with Paoli Peaks, internal advertising and promotion, purchase and redemption process.

Advertising

Paoli Peaks agrees to supply the partner with necessary promotional materials to encourage employee participation in the benefits program. The partner must agree to display Corporate Partner Program and related information on company information bulletin boards; advertise the availability of the Corporate Program on internal newsletters and the like; and make available any additional promotional opportunities. Paoli Peaks is happy to schedule a representative visit to the partner's workplace during the launch of this program.

Corporate Discount Ticket Distribution

Corporate Discount Ticket are available for purchase via your companies' office login at www.paolipeaks.com online shopping cart only. Discounted ticket guidelines include:

- Your Company's official Login and Discounts are not to be distributed to the general public. Any partner found doing so will be removed from the Corporate Partner Program.
- Discounts are valid for any full- or part-time employee.
- Employees may purchase the discounted tickets for their immediate family members (as defined by dependents). Employees may not use discounts for non-dependent guests. Any employee found doing so will forfeit their ability to redeem discounted tickets.
- Discounted Corporate tickets have no cash value and are prohibited from resale.

Corporate Discount Ticket Redemption

- When purchasing tickets, employees will choose which day they plan on visiting. Discounted tickets are valid only for the day chosen by the employee at the time of purchase. All tickets expire End of Season.
- Discounted tickets cannot be applied to snow tubing.
- To redeem, employees must present a valid company ID and photo ID to the Paoli Peaks Ticket Windows. Valid Company IDs may include an employee badge, paycheck stub, insurance card, or other approved ID method as outlined on the Corporate Enrollment Form.
- Immediate Family members using a corporate ticket must accompany the employee to the Ticket Windows.
- Employees without a valid company ID present may be refused the discounted rate at the discretion of Paoli Peaks.

Redemption continued....

- Employees without a valid company ID present may be refused the discount at the discretion of Paoli Peaks.

Program Rewards

Paoli Peaks agrees to reward outstanding partners with additional incentives. For every twenty-five (25) Corporate Tickets Redeemed, one (1) complimentary All Day Adult lift ticket voucher will be issued to the partner. Complimentary tickets may be utilized at the company’s discretion, however are prohibited from resale. Rewards will be tallied and processed intermittently throughout the season on the following dates: December 31, January 31, February 28, and March 31. Reward tickets processed prior to March 1, will be issued for use during the current season; reward tickets processed on or after March 1, will be issued for use during the following winter season contingents upon partnerships renewal.

The terms of participation in the Corporate Partner Program commence upon receipt of this completed agreement, in conjunction with the Enrollment & Order Form. If the partner wishes to dissolve the program at any time, please send a written statement to Paoli Peaks.
